Document description: this document contains a detailed description of licenses, which may be operated within the product. Prices of individual licenses are not mentioned here and may be found in a price list published on authors pages <http://www.vetsoftware.eu>

Introduction

As opposed to the first version of the program, the points at issue regarding the licenses have now been fully reworked. Changes are mostly rising from information and comments from the users of our software. This results in a number of basic variants of license use.

Basic description of licenses

- individual licenses are stored in license files. A license file may be acquired through electronic mail, downloading from the Internet or by a CD with the program
- licenses are not time-limited, the license owner may use it for an indefinite period of time (considering the protective elements, see below)

Protective elements of licenses

In order to protect individual licenses against possible misuse, following rules apply to licenses:

- client data stored in the license cannot be changed in the application; change is possible upon agreement with the author only
- individual license files are ciphered; any attempt to change it will result in impairment of the license
- validity of the license file is limited to 12 months, renewal of file's validity of **FREE OF CHARGE** and the client will be informed by the program about the necessity to renew the license file prior to the expiry
- the author reserves the right to change the license validity in case of need

Basic structure of licenses

Licenses differ depending on possibility of use in the program:

- a) license of medical room/company – program registration (**LO**)
- b) doctor's license (**LL**)
- c) unlimited doctor's license (**NLL**)
- d) user's license (**LU**)
- e) demo license (**LD**)

Labels in brackets are used in the pricelist.

General description of license use possibilities

It is possible to operate the "VetSoftware V2" program in the following manner:

- by an independent doctor
- by more independently working doctors (each having their data on accounting documents)
- more doctors, presented on accounting documents by data (name, Id.No.) of one of the doctors
- another subject (e.g. ltd., corporation) presented on accounting documents by own data

Description of individual licenses

A) LICENCE OF MEDICAL ROOM/COMPANY

- license file contains the following data: name of establishment, street, post code and city, Id.No., company name for print setup
- address (street, post code, city) is used for printing of tax document headers
- this license does not allow work in the program; it is a basic registration and allows logging in as an administrator and insert further licenses or users
- this license is **FREE OF CHARGE**

B) DOCTOR'S LICENSE

- license set contains the following data: title, name and surname, Id.No., number of General Medical Council
- doctor's license is time-limited (see Protective elements of licenses)
- license is bound to medical room/company
- renewal of license validity is **FREE OF CHARGE**

C) UNLIMITED DOCTOR'S LICENSE

- extended doctor's license is not bound to license of medical room/company, it may be used in any installation of the program regardless of their number
- validity time of the license is determined by the client, it's possible renewal is **FREE OF CHARGE**
- any number of licenses of medical room/company will be created for the owner

D) USER LICENSE

- user has the same right for work in the program as the owner of doctor's license
- user license **does not** contain an identification number
- it may be extended to a doctor's license for a fee (LL)
- license is suitable for operation in locations (e.g. larger medical rooms, hospitals) where accounting documents contain data mentioned in doctor's or medical room license and where more users are working with is e.g. nurses or other personnel
- license is more price favourable and allows saving of acquisition costs

E) DEMO LICENSE

- demo license is designed to test the functionality of the application
- application is fully functional for the period of 30 days, 5 clients and 5 patients
- in demo license doctor has "name surname", registration of medical room is "Company"
- in case of interest it is possible, upon request, to create a fully valid license **FREE OF CHARGE** containing valid user data, without limit to the number of client and patients; validity period is determined as agreed

Case studies

Below are mentioned cases of use and description of necessary licenses.

Description	License awarded
1. I'm an independently working veterinarian and I'm interested in operating the program alone on my computer	- program registration issued on doctor's data - doctor's license registered on doctor's data
2. We are two independently working doctors, we both present ourselves on accounting documents by our respective data	- program registration issued on medical room data - two doctor's licenses registered on doctor's data
3. We are three operating doctors, presented on accounting documents by the data of one of us only	- program registration issued on medical room data - doctor's license registered on doctor's data - two user licenses
4. We are a limited company and employ 10 doctors, accounting documents will be issued with company data	- program registration issued on medical room data - ten user licenses

FAQ

1. *You state that the license is time-limited, but in the paragraph about protection you mention a period of 12 months. Which data applies?*

12 month limit is really merely for the reason of protection of the license from misuse and thus also protects the investments of our clients. Every valid license will be renewed prior to expiry **free of charge**.

2. *Is the unlimited doctor's license as unlimited as you claim?*

Yes, unlimited doctor's license may be used in any number of medical rooms/companies. Upon request a license will be generated for the owner for further medical rooms/companies and that **free of charge**. Regarding the licensing costs, the owner will never in the future have to pay for further use. Such license is, generally said, "forever".
